### **4. Open Forum/ Submissions from the public**

A resident attended from the Cogshall Lane area and raised concerns in respect of the management of the works to the highway on the main road between Anderton and Comberbach. The Parish Council had been advised that the works would be done one side at a time, leaving the route passable for residents and businesses. This was not the case. We also heard that operatives had remonstrated with a resident at a nearby farm who was returning home.

Cogshall Lane was not available as a diversion due to flooding/works occurring there and this meant that two main routes into and out of the village were blocked.

Resident also highlighted issues around parking at the junction of Marbury Road/Cogshall Lane and enquired about the possibility of double yellow line.
