#### 1) Attendance

### 4) Minutes of meeting of 26 January 2021

#### 4) Ward councillors report

- A Cheshire West and Chester (CWAC) cross party Flood Risk management group and an Action Group had been set up. They would meet in April to discuss the Northwich area.
- The COVID board continued to meet.
- The area is in purdah due to the PCC elections and Ward councillor elections for Frodsham and Ellesmere Port.
- CWAC's AGM would be held on 23 April to enable the use of a virtual meeting.
  - Cllr Gibbon would continue to press CWAC for lists or maps of drains and gullies which councillors would add to using their local knowledge. She advised that activities such as grass cutting and litter picking were moving in house.
  - The canal remained closed at Barnton Shutes due to a landslip. It might prove necessary to relocate the gas main. A multiagency meeting was planned to resolve issues.
  - Cllr Gibbon was pursuing the removal of an Ash Tree root from Cogshall Lane.

- a) The Clerk thanked the councillors for her retirement gift of a bird table.
- b) **Planters** -these were due to be delivered from Northwich Town Council in the Spring.
- c) Councillors O and R Hynes would deal with the **Accessibility statement** for the website.

- e) Cllr Brewin reported that she remained hopeful of funding for a Speed Indicator Device.

- A book of Remembrance was open for those who had lost people to COVID.
