

## MEETING OF ANDERTON WITH MARBURY PARISH COUNCIL

Chairman opened the meeting at 7pm

### 2) Attendance

Councillors Bullock, Green, O Hynes , R Hynes and Walmsley were present with apologies from councillors Byram and Wright and CWAC councillors Wright, Hammond and Gibbon.

#### 4) Clerks report

- Cllrs decided not to purchase a silhouette of a WW1 soldier at a cost of £750.

- A brine leak in July had affected 7-8 large trees in Marbury and an arboriculturalist was pessimistic about their survival as the land was saturated with brine. Action would be delayed until spring to see whether their leaves sprouted and costs would be recovered.
