The Chairman opened the meeting at 7pm

- 1) Councillors Bullock, O Hynes, R Hynes, Green, Walmsley and Wright were present with apologies from Cllr Byram and CWAC councillors Wright, Hammond and Gibbon.
- 2) Declarations of interest
As all councillors lived in the vicinity of the village they all had personal interests.
- 3) The Clerk would contact the Barnton Clerk re water runoff from Gunnersclough Wood affecting Hough Lane.
- 4) Minutes of Meeting held on 25 September 2017

- 5) Clerks report
 - The gardener would be asked to trim the hedge along the hall carpark when he cut the grass in the autumn unless Cllrs Bullock and Wright could make alternative arrangements. Cllr Wright would contact Mr Whalley.
 - The Clerk had written to The Local Government Boundary Commission supporting the recommendation that the parish should stay within an enlarged Marbury ward.
 - The Chairman had written to the CEO of Cheshire West and Chester opposing the badger cull.
- 6) Correspondence
 - Councillors noted the Friends of Anderton and Marbury reports
 - Councillors noted bulletins from the police and crime commissioner
 - Councillors noted bulletins from CHALC.
 - Incident at Anderton- a dog had been shot after worrying sheep. The Clerk had emailed the dog's owner and had met with the Forestry Commission ranger to check that fences were stockproof.
 - Cheshire West and Chester budget consultation-individual councillors would respond.
 - Northwich Transport Strategy consultation- the Chairman would attend the CWAC full council meeting on 14 December to put the parish council's views forward in a short submission. There were views for and against re opening Marbury Lane but councillors were opposed to a road running around the north of Barnton to Little Leigh. A route via Weaverham to the A49 was favoured. In addition individual councillors and members of the public were urged to respond to the consultation. Details would be placed on the parish council website.
 - The Clerk would write to the parliamentary boundary commission supporting the recommendation that Anderton with Marbury should join Weaver Vale.
